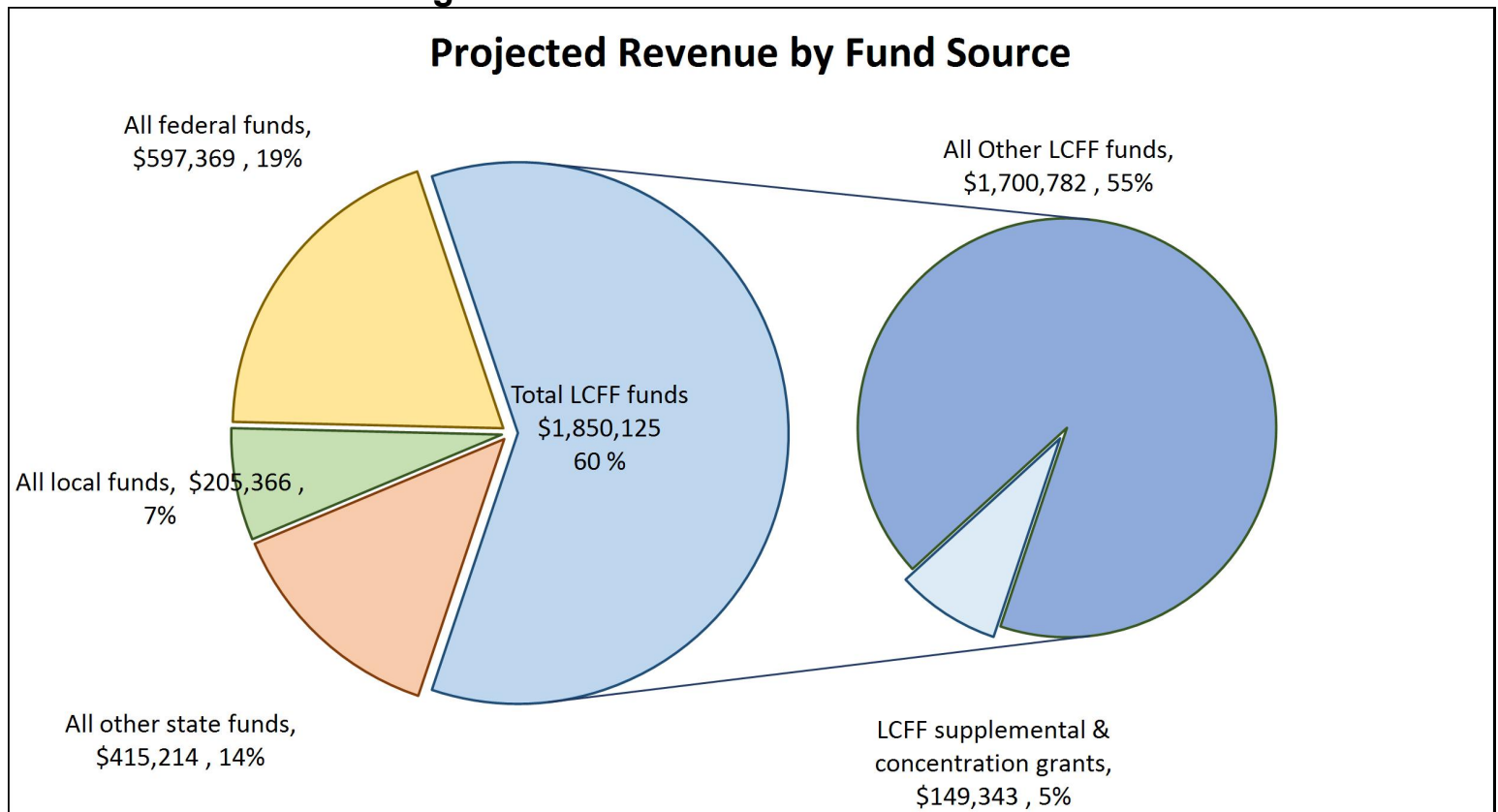

### Budget Overview for the 2026-27 School Year

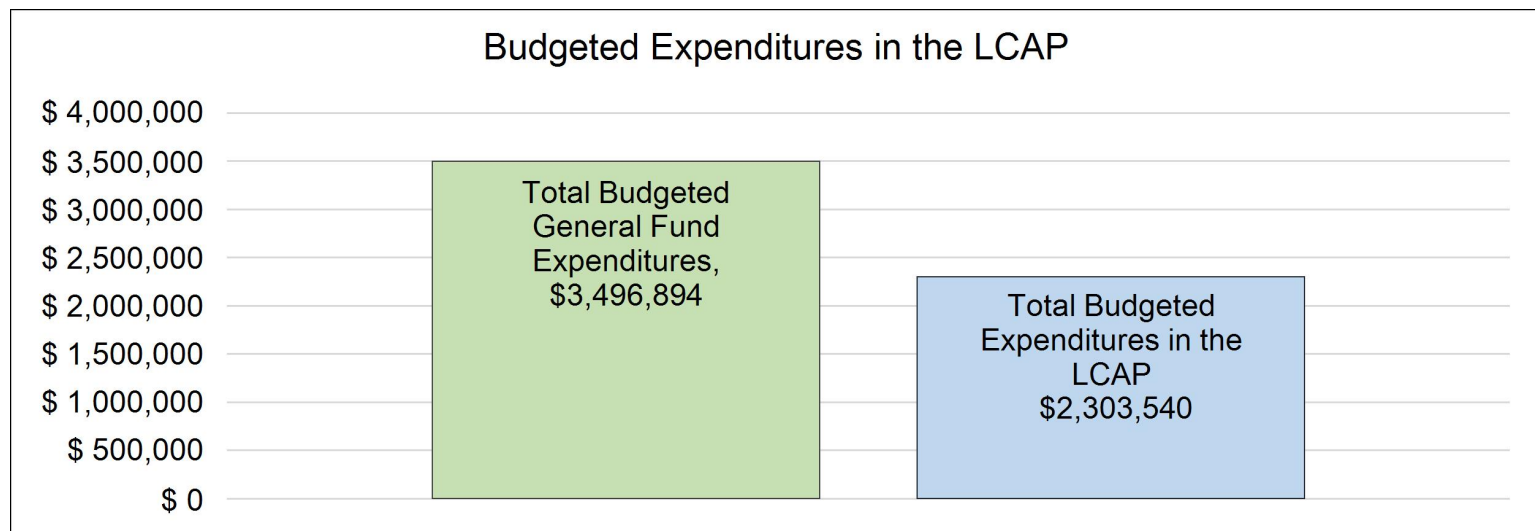


This chart shows the total general purpose revenue Two Rock Union Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Two Rock Union Elementary School District is \$3,068,074, of which \$1,850,125 is Local Control Funding Formula (LCFF), \$415,214 is other state funds, \$205,366 is local funds, and \$597,369 is federal funds. Of the \$1,850,125 in LCFF Funds, \$149,343 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

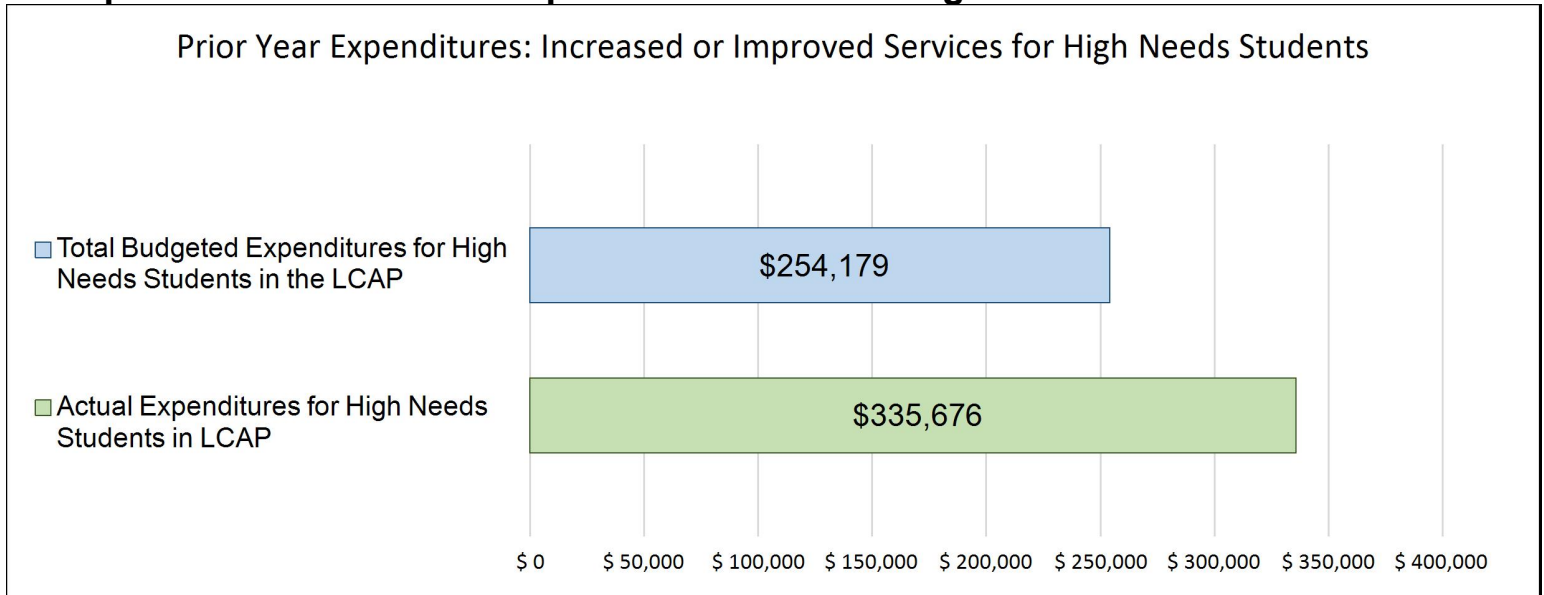

In 2026-27, Two Rock Union Elementary School District is projecting it will receive \$149,343 based on the enrollment of Foster Youth, English learner, and low-income students. ## Plan Summary [2026-27]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA. LEAs may also provide information about their strategic plan, vision, etc.

Two Rock Elementary School is a single school, school district located in rural southwest Sonoma County. Two Rock currently has an enrollment of 149 students in grades TK-6. The school also houses a preschool program. The South County Consortium program is for students with disabilities. Approximately 60% of the school's diverse student population comes from the United States Coast Guard Training Center (TRACEN) located adjacent to the school site. The remaining population comes from the families living on the surrounding ranches and dairies, along with other students on inter-district transfers. Our student body is comprised of approximately 29% English Language Learners, 46% socially economically disadvantaged (SED), and 0% foster youth. The total unduplicated pupil count is 54.8%. Two Rock Elementary School offers a full educational program to our students which includes physical education, music, library, and gardening. We employ a .60 FTE special education teacher. The site has instructional aides for all grade levels to support students in both English and Spanish. Students also benefit from counseling, speech, occupational therapy, and psychological services. We offer an ELOP-funded before-school care program and an ELOP and ASES-funded after-school program, as well as ELOP and District-funded summer intervention programs in mathematics and reading. Afterschool sports are also offered. The District utilizes standards-aligned curriculum in science, social science, and mathematics. Parent participation has significantly increased in the past two years. A challenge we face is that many students come from the Coast Guard Training Facility where parents may be deployed for long periods leaving one parent at home with students. We also encounter the challenge of supporting students who have recently arrived from other countries and have limited English language skills. Their parents may also speak little to no English, which can make it difficult for them to adjust to a new community and school environment. The District's Mission is to foster a shared responsibility for encouraging creativity while developing every child's academic and social skills as a foundation for lifelong learning. The District's Vision is that all students will be challenged and prepared for rigorous standards in an environment of equity, respect, and responsibility.

There are no schools eligible for the equity multiplier funds in the Two Rock Union School District. This LCAP serves as the district's strategic plan.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

### 2023 DASHBOARD

Our performance based on the 2023 CAASPP Results and 2023 Dashboard is positive overall with 48.39% of students meeting or exceeding standards in English language arts (ELA) and 40.32% of students meeting or exceeding standards in math. However, learning gaps exist for low-income students in both academic areas. In ELA, 25.81% of low-income students met or exceeded standards and, in math, only 12.90% of low-income students met or exceeded standards. Significant achievement gaps also exist for English learners with 10% meeting or exceeding standards in ELA and 5% meeting or exceeding standards in math. Another significant student group where achievement gaps exist is Hispanic youth with 29.41% meeting or exceeding standards in ELA and 20.58% meeting or exceeding standards in math.

In 2023, English learner progress as measured by the English Learner Progress Indicator (ELPI) and the English Language Proficiency Assessments for California (ELPAC) included 52.9% making progress toward English language proficiency. The number of English learners included in this measure was 34 students.

In 2023, chronic absenteeism decreased to 21.9% from 26.8% in 2022. The suspension rate also decreased to 0% in the 2022-23 school year.

### 2024 DASHBOARD UPDATE

In 2023-24, our performance based on the 2024 CAASPP Results and 2024 Dashboard indicates a decrease in academic performance overall in ELA and an increase in academic performance in math and science. In 2024, the percentage of students who met or exceeded standards in ELA decreased to 38.33% from 48.39% in 2023. Whereas in math, the percentage of students who met or exceeded standards in 2024 increased to 46.66% from 40.32% in 2023. Learning gaps continue to persist for low-income students. However, significant progress was made in 2024 for low-income students. In ELA, 27.27% met or exceeded standards compared to 25.81% in 2023. In math, 39.39% of low-income students met or exceeded standards in math in 2024 compared to 12.90% in 2023. English learner performance also decreased in ELA in 2024 to 0% meeting or exceeding standards from 10% in 2023. In math, there was a slight increase for English learners to 15.38% meeting or exceeding standards compared to 15% in 2023. Finally, Hispanic youth followed the same pattern with a decrease in ELA proficiency from 29.41% meeting or exceeding standards in 2023 to 25.72% in 2024. In math, Hispanic youth increased their performance from 20.58% meeting or exceeding standards in 2023 to 22.85% in 2024. In science, there was a significant increase in the percentage of students meeting or exceeding standards. In 2023, 25% of students met or exceeded standards. In 2024, this percentage increased significantly to 72.72% meeting or exceeding standards in science.

In 2024, English learner progress as measured by the ELPI included 44.4% making progress toward English language proficiency. The number of English learners included in this measure was 27 students.

In 2024, chronic absenteeism decreased again to 11.3% from 21.9% in 2023. The suspension rate also sustained at 0% in the 2023-24 school year.

## 2025 DASHBOARD UPDATE

In 2024-25, our performance based on the 2025 CAASPP Results and 2025 Dashboard indicates a increase in academic performance overall in ELA and an decrease in academic performance in math and science. In 2025, the percentage of students who met or exceeded standards in ELA increased to 43.06% from 38.33% in 2024. In math, the percentage of students who met or exceeded standards in 2025 decreased to 43.84% from 46.66% in 2024. Learning gaps continue to persist for low-income students. Progress was not made in 2025 for low-income students. In ELA, 27.27% met or exceeded standards compared to 27.27% in 2024. In math, 35.30% of low-income students met or exceeded standards in math in 2025 compared to 39.39% in 2024. English learner performance increased in ELA in 2025 to 5.88% meeting or exceeding standards from 0.00% in 2024. In math, there was a slight increase for English learners to 16.67% meeting or exceeding standards compared to 15.38% in 2024. In science, there was an increase in the percentage of students meeting or exceeding standards. In 2024, 30.70% of students met or exceeded standards. In 2025, this percentage increased to 32.66% meeting or exceeding standards in science.

In 2025, English learner progress as measured by the ELPI included 50% making progress toward English language proficiency. The number of English learners included in this measure was 12 students.

In 2025, chronic absenteeism decreased again to 5.9% from 11.3% in 2024. The suspension rate also sustained at 0% in the 2025-26 school year.

## LOCAL ASSESSMENT RESULTS

The local STAR assessments in reading and math show mixed results in the percentage of students at or above proficiency. The percentage of students who are at or above proficiency in reading increased from 57% in 2024-25 to 59% in 2025-26. In the area of math, the percentage of students who are at or above proficiency in math decreased from 56% in 2024-25 to 54% in 2025-26. For each significant student group mixed results were also evidenced on the local assessments in 2025-26. The percentage of English learners who are at or above proficiency in reading increased from 13% in 2024-25 to 17% in 2025-26, low-income students at or above proficiency increased from 50% in 2024-25 to 83% in 2025-26, and Hispanic youth at or above proficiency in reading increased from 38% in 2024-25 to 41% in 2025-26. The percentage of English learners at or above proficiency in math increased from 25% in 2024-25 to 46% in 2025-26, low-income students at or above proficiency decreased from 83% in 2024-25 to 46% in 2025-26, and Hispanic youth at or above proficiency decreased from 55% in 2024-25 to 46% in 2025-26.

## JANUARY 2026 YOUTH TRUTH SURVEY RESULTS

The 2026 YouthTruth Student Survey showed some areas of concern related to school safety and belonging. In 2026, 57% of students reported feeling safe at school compared to 45% in 2025. Also, when students were asked if they feel like they are an important part of their school, 33% agreed compared to 25% in 2025. Two areas of strength in the Student Survey are that 93% of students agree their teacher wants them to do their best and 84% agree their teacher treats them with respect. The 2026 YouthTruth Family Survey showed some promising results with 83% of parent/family members feeling they are engaged with my child's school. Also, 73% of parent/family members feel represented by parent/family groups. In the area of safety, 80% of respondents feel their child's learning environment is safe and 71% say their child is safe from bullying during school. The 2026 YouthTruth Staff Survey also shows a result relating to safety with 64% of staff members reporting they feel safe from harm while at school.

## A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Engagement opportunities with educational partners were facilitated throughout the year in both English and Spanish to gather meaningful input on the District's three LCAP goals. Educational partners included parents, ELAC members, School Site Council members, certificated and classified staff, students, SELPA representatives, and community members. During these collaboration opportunities, stakeholders reviewed CAASPP results, local assessment data, YouthTruth Survey results, attendance data, English Learner progress data, and school climate information to identify strengths, areas of need, and priorities for improvement. The goals and actions were also presented during ELAC sessions, where Spanish-speaking parents were provided opportunities to share feedback regarding English learner supports, communication needs, and school programs. At the May Open House event, LCAP goals and progress were shared publicly, and additional input opportunities were provided. Throughout the school year, parents and staff continued to engage in discussions regarding the educational program at Two Rock Elementary School.

Stakeholder feedback directly influenced the development of specific LCAP actions, services, and expenditures. Educational partners consistently identified the need to improve English Learner achievement, strengthen literacy and mathematics instruction, increase intervention support, improve communication with families, and expand opportunities for parent engagement. Staff members emphasized the need for updated curriculum resources, professional development in literacy and language acquisition strategies, and systems to better support struggling students. Parents and ELAC members identified the importance of bilingual communication, targeted support for newcomers and English learners, and increased opportunities for family participation in the school community. Feedback from military-connected families also highlighted the importance of maintaining strong communication and relationships due to the challenges associated with deployments and transitions.

As a result of this stakeholder input, several specific actions were developed or revised within Goal 1 to address academic achievement and intervention needs. Feedback regarding literacy gaps and English learner achievement led to the continuation of bilingual instructional assistant support for English learners and newcomers (Goal 1, Action 1.2). Stakeholders also emphasized the need for targeted intervention services, resulting in the implementation of literacy intervention through SIPPS and Orton-Gillingham programs (Goal 1, Action 1.4) and targeted math intervention support through a 0.4 FTE intervention teacher (Goal 1, Action 1.7). Educational partners identified professional development as a priority, which directly influenced Goal 1, Action 1.6, providing staff training in literacy interventions, ELD strategies, SIPPS, and Orton-Gillingham practices. Additionally, stakeholder requests for updated instructional materials and stronger support for English learners directly informed the adoption of a new mathematics curriculum and pilot of a new ELA curriculum with differentiated supports for English learners (Goal 1, Action 1.8). Stakeholder feedback regarding the importance of monitoring student progress and utilizing assessment data also supported continued funding for programs such as Lexia, STAR, DIBELS, and IXL (Goal 1, Action 1.9).

Stakeholder input also strongly influenced Goal 2 actions related to parent engagement and communication. Parents and community members emphasized the importance of meaningful opportunities for involvement and accessible communication in both English and Spanish. This feedback directly informed actions to utilize YouthTruth Survey, ELAC, and LCAP feedback to guide school culture and engagement efforts (Goal 2, Action 2.1), continue translation and outreach services for Spanish-speaking families (Goal 2, Action 2.2), and expand parent engagement opportunities through family nights, cultural events, and Open House activities (Goal 2, Action 2.3). Feedback from Coast Guard and military-connected families also informed Goal 2, Action 2.4, which prioritizes partnerships and communication systems that support military-connected students and families.

Under Goal 3, educational partners emphasized the importance of maintaining a safe, welcoming, and supportive school environment where students feel connected and engaged. Feedback from the YouthTruth Survey, SSC, staff collaboration opportunities, and parent discussions highlighted the importance of school climate, attendance, student connectedness, and social-emotional supports. This feedback informed the continuation of actions and services focused on improving attendance, monitoring school climate, supporting student engagement, maintaining safe school facilities, and ensuring access to broad learning opportunities and student support systems designed to support students academically, socially, and emotionally.

### An explanation of why the LEA has developed this goal.

Two Rock established this goal to improve literacy and math outcomes for all students, recognizing that many currently read below grade level. This aligns with the District's objective of ensuring all students read at or above grade level. According to the 2025 CAASPP state assessment, 43.06% of students met or exceeded the standard in English Language Arts (ELA), and 43.84% met or exceeded standards in math. Student achievement in ELA increased by 4.73% and in Math decreased to 2.82% from the previous year. In 2024-25, 5.88% of English learners (ELs) met or exceeded standards in ELA and 16.67% in math. The goal includes metrics to monitor student performance in both ELA and math. The planned actions will allocate resources and support, particularly for targeted groups such as English learners and low-income students, while benefiting the entire school community.

## Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

### SUCCESSFUL ACTIONS:

1.1 Highly Qualified Teachers. This action was fully implemented as planned with no significant challenges. The District was successful in hiring and/or retaining highly qualified teachers for all of the regular education classes including intervention.

1.2 Provide Instructional Assistants in the classroom. This action was fully implemented as planned with no significant challenges. The District was successful in providing instructional assistant support in the K-6 classrooms.

1.3 Provide a bilingual Instructional Assistant for ELL students, long-term EL students, and newcomers. This action was fully implemented as planned with no significant challenges. The District was successful in funding and retaining bilingual instructional assistants in support of students in the 2025-26 school year.

1.4 Provide Induction and Intern support for beginning teachers. This action was fully implemented as planned with no significant challenges. The District overestimated costs for this action, but it did not affect the implementation level of this action. The District successfully provided the Teacher Induction Program in partnership with the North Coast School of Education.

1.5 Provide intervention services for students who are performing below grade level in literacy and mathematics and add additional intervention to ELL students. This action was fully implemented as planned with no significant challenges. Intervention instruction was provided by the .50 FTE teacher who also teaches TK.

1.6 Provide support services for students. This action was implemented as planned. The District was able to provide RSP services by hiring a credentialed RSP teacher.

1.7 Provide staff development in reading and literacy acquisition, mathematics, and other core curriculum. This action was partially implemented as planned. The District funded professional development for teachers in the areas of early reading literacy. In 2025-26 two teachers were trained in the Orton-Gillingham reading approach. The District has contracted for the implementation of the K-3 Proficiency reading program. The District has adopted a new Math curriculum called Bridges and a English Language Development (ELD) program called Lexia English, in Spring 2026. A new ELA curriculum will be piloted in Fall 2026, including the Thinking Maps supplemental writing program.

1.8 Intervention teacher. This action was implemented as planned.

1.9 Adopt math and ELD curriculum for grades TK-6 with resources to support ELL students. This action was partially implemented as planned. The District piloted math materials and did select a math curriculum for ongoing use in the classroom in the 2025-26 school year. A new ELA curriculum will be piloted in Fall 2026.

1.10 Lexia, STAR, DIBELS; and IXL. This action was fully implemented as planned with no significant challenges. The District purchased and implemented all these programs listed within the action.

1.11 ELPAC Testing. This action was fully implemented as planned with no significant challenges. The District hired a retired ELD teacher to coordinate and administer the ELPAC tests to students who are identified as English Language Learners.

1.12 Reduce class size and eliminate combination classes. This action was fully implemented as planned with no significant challenges. The District hired an additional 1.0 FTE additional General Education teacher using supplemental funds to reduce class size.

1.13 Data technician/front office secretary. This action was fully implemented as planned with no significant challenges. The position of Data Technician was maintained to support student data collection.

1.14 Professional development for teachers to support ELL/long term EL students. This action was partially implemented as planned with no significant challenges. The District, in partnership with Sonoma County Office of Education and Lexia will provide designated English Language Development (ELD) professional development for the instructional staff.

#### CHALLENGING ACTIONS:

1.4 Provide Induction and Intern support for beginning teachers. This action was fully implemented as planned with challenges. While The District successfully provided the Teacher Induction Program in partnership with the North Coast School of Education it was challenging to find mentor to serve as supportive providers for our teachers.

1.5 Provide intervention services for students who are performing below grade level in literacy and mathematics and add additional intervention to ELL students. This action was fully implemented as planned with challenges. Intervention instruction was provided by the .50 FTE teacher who also teaches TK. Our TK teacher went on leave and the change in personnel delayed the start of the program. Additionally, our RSP teacher was not able to support this program due to a larger than expected caseload.

1.8 Intervention teacher. This action was implemented as planned with challenges. Our TK teacher went on leave and the change in personnel delayed the start of the program. Additionally, our RSP teacher was not able to support this program due to a larger than expected caseload.

1.9 Adopt math and ELD curriculum for grades TK-6 with resources to support ELL students. This action was partially implemented as planned. The District piloted math materials and did select a math curriculum for ongoing use in the classroom in the 2025-26 school year. A new ELA curriculum will be piloted in Fall 2026.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The following actions had material differences:

- 1.2- Added an instruction assist position mid-year to provide greater intervention support.
- 1.4 The District had estimated more in induction program fees than necessary.
- 1.6 This is due to an increase in South County Consortium placements.
- 1.7- Cost for PD came in higher than anticipated
- 1.9- Math pilot materials purchased in prior year for kinder were able to be used in 2025-26 and reduced the over math adoption costs.
- 1.10 The cost of the software licensing was less than originally estimated.
- 1.11-
- 1.12 The variance is due to final staffing and H&W costs.
- 1.13 The variance is due to final staffing costs.
- 1.14 Based on actual cost.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Actions 1.1, 1.2, and 1.12

Action 1.1 (Highly Qualified Teachers), Action 1.2 (instructional assistants), and Action 1.12 (small class sizes) work together to provide students with effective classroom learning environments that provide for small class sizes with differentiated supports. These actions were partially effective in making progress toward the goal as measured by overall increases in ELA performance and overall increases in math performance on statewide assessments. The local STAR assessments in reading and math partly support the effectiveness of this action. The percentage of students who are at or above proficiency in reading increased from 57% in 2024-25 to 59% in 2025-2026. In the area of math, the percentage of students who are at or above proficiency also decreased from 56% in 2024-25 to 54% in 2025-2026. The statewide assessments in math demonstrate the effectiveness of the instructional assistants for English learners and low-income students. These groups benefited from the differentiated, small-group instruction supported by the instructional assistants. In 2024-25, 16.67% of English learners met or exceeded standards in math compared to 15.38% in 2023-24. In 2024-25, 35.29% of low-income students met or exceeded standards in math compared to 35.71% in 2023-24. In ELA, performance for English learners increased. In 2024-25, 5.88% of English learners met or exceeded standards in ELA compared to 0% in 2023-24. The performance of low-income students increased in ELA in 2024-25 to 27.27% from 25% in the previous year.

#### Actions 1.3, 1.5, 1.7 and 1.14

During the 2025-26 school year, Action 1.3 (bilingual instructional assistant), Action 1.5 (academic interventions), 1.7 (PD in literacy and bilingual education), and Action 1.14 (PD to support English learners) worked together and were effective in providing support predominately for English learners, long-term English learners and newcomers with the acquisition of English and access to the English Language Development (ELD) standards and core content standards. Bilingual instructional assistants provided primary language support in small groups in the classroom. Action 1.5 focused on English learners by providing an additional intervention specifically for English learners. Professional development focused on literacy through Orton Gillingham training and K-3 literacy training. These actions were partially effective in making progress toward the goal of English language acquisition. The local STAR assessment showed gains for English learners in reading from 13% at or above proficiency in 2024-25 to 17% in 2025-26. In the statewide ELA assessment for 2023-24, 0% of English learners met or exceeded standards in ELA, but in 2024-25, that percentage increased to 5.88%. Also, English Learner Progress Indicator which measures performance on the English Language Proficiency Assessments for California (ELPAC) increased from 44.4% making progress toward English language proficiency in 2023-24 to 50% in 2024-25. It is important to note that the number of English learners was less than 30 students in 2023-24. For this reason, proficiency scores can be unstable. On the 2025 Dashboard, the ELPI was not assigned a color due to insufficient data.

Action 1.4 provides induction support for beginning teachers. During the 2025-26 school year, the District funded the induction program for first- and second-year teachers and intern program for teachers who were in an credential program. This action was effective in making progress toward the goal, as demonstrated by the teacher's active and positive participation in the induction and intern process. Metric 1.3 showed a decrease in 33% of teaches who are fully credentialed. This action is imperative to support new and intern teachers in clearing their credential and having support to stay in the profession successfully.

Action 1.6 provides funding for a credentialed Resource Specialist Program (RSP) teacher to support students with IEPs and students with identified learning challenges, a licensed Speech and Language Pathologist (SLP), and a Special Education Director to provide a comprehensive special educational program. This action was effective in making progress toward the goal as evidenced in the District's ability to recruit a credentialed RSP teacher. The District was able to provide support to students with IEPs and students with identified learning challenges. English Language Arts achievement increased from 38.3% to 43.1% meeting/exceeding standards. Mathematics achievement remained strong at 43.8% meeting/exceeding standards.

Action 1.8 provided a intervention teacher to support students for three hours a day. This action was effective in making progress toward the goal as evidenced by increases in both statewide and local assessments. The percentage of students meeting or exceeding standards as measured by the statewide assessments increased 37 points in ELA and 5.9 points in Math. The increase for low-income students was even greater with an increase 44.1 points in ELA and no performance color in Math. On the local assessment, the percentage of students at or above proficiency in reading increased from 57% in 2024-25 to 59% in 2025-26. In Math, there was a decrease from 56% in 2024-25 to 54% in 2025-26.

#### Action 1.9

In the 2025-26, the District adopted a new math curriculum for grades TK-6 with resources to support English learners. The action was effectively completed during the Spring and the implementation process will continue in the 2026-27 school year. A new ELA curriculum will be piloted in Fall 2026. 100% of students have access to standards-aligned instructional materials.

#### Action 1.10

Lexia, Renaissance Learning, DIBELS, SIPPS and IXL are programs the District provides to teachers to assist with monitoring student progress and support teacher collaboration time as they work collaboratively to use data to guide the instructional process. This action was effective in making progress toward the goal as evidenced by increases in reading and math on the local STAR assessments. The percentage of students who are at or above proficiency in reading increased from 57% in 2024-25 to 59% in 2025-26. In Math, there was a decrease from 56% in 2024-25 to 54% in 2025-26. Additionally, teachers expressed high levels of satisfaction with their collaborative work, indicating that the programs effectively support their instructional efforts. This is further supported by the 2025–26 YouthTruth Staff Survey results, in which 71% of teachers agreed with the statement, “I have the necessary resources to do my job well.”

#### Action 1.11

The District hired a retired ELD teacher to coordinate and administer the ELPAC tests to students who are identified as English language learners. This action was effective in making progress towards the goal as all English learners completed the ELPAC assessments within the required statewide deadlines. English Learner Progress Indicator (ELPI) increased by 5.6 %.

#### Action 1.13

The District funded a Data Technician position to support student data collection. This position was effective in making progress toward the goal by effectively assisting the District Superintendent with documenting and tracking student data to make data-informed decisions. The effectiveness of this action is evidenced by the increase in the attendance rate from 94.43% in 2024-25 to 95.85% in 2025-26, the decrease in the chronic absenteeism rate from 11.3% in 2023-24 to 5.9% in 2024-25, and the maintenance of the suspension rate at 0%.

## Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

### SUCCESSFUL ACTIONS:

Action 2.1 used information from the YouthTruth Family Survey, along with input from ELAC meetings, School Site Council meetings, the Two Rock School Education Foundation meetings, and school staff to provide parents with opportunities to be involved in their child's education. This action was fully implemented as planned with no significant challenges. During the 2025–26 school year, there was only a slight change in the percentage of parents participating in ELAC and TRSEF meetings, representing continued success in family engagement efforts.

Action 2.2 provided translation services for Spanish-speaking parents. This action was successful and fully implemented as planned with no significant challenges. Two Rock's Community Liaison provided translation services for the school and teacher newsletters and served as the face of the front office. She also served as the interpreter for meetings and other school functions when an interpreter was needed. The site also has a bilingual instructional assistant who provided services for parents, especially during parent/teacher conferences, Back to School Night, Open House, and other evening events with parent participation. Additionally, a bilingual staff member facilitated ELAC meetings.

Action 2.3 provided for parent and family engagement through activities such as monthly assemblies, Back to School Night, Open House, and other events for families and cultural events. This action was fully implemented as planned.

Action 2.4 focuses on maintaining relationships with military-connected families since nearly 60% of students who attend Two Rock are from the adjacent Coast Guard base. This action was fully implemented as planned with frequent and consistent communication occurred with

families during the 2025-26 school year. Significant challenges were associated with the implementation of this action due to multiple government shutdowns.

#### CHALLENGING ACTIONS:

Actions 2.1, 2.2, 2.3, and 2.4 were implemented as planned and remained strong throughout the previous year. The district continued to provide opportunities for educational partners to participate, share feedback, and engage in school and district activities. Communication, transparency, and family engagement efforts contributed to a collaborative and supportive learning environment for students.

While implementation was successful overall, participation was not always as broad or representative as intended. Survey response rates and engagement opportunities varied among educational partner groups, limiting the range of perspectives included in some planning and decision-making processes. Moving forward, the district will focus on increasing survey participation, providing additional and more accessible opportunities for meaningful feedback, and strengthening communication and outreach to ensure that input reflects the diversity of the school community.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Actions 2.1–2.4 were collectively effective in strengthening family engagement, representation, and communication, although opportunities remain for continued growth.

Action 2.1 was partially effective. YouthTruth Family Survey results indicate modest progress in parents' sense of representation and participation in school decision-making. The percentage of parents who felt empowered to play a meaningful role in decision-making increased from 63% to 64%, while those who felt represented by parent and family groups increased from 67% to 73%. Overall family engagement remained strong and unchanged at 83%. These results demonstrate progress but also indicate a need to create additional opportunities for meaningful and representative parent input.

Action 2.2 was effective in supporting Spanish-speaking families. Translation services helped reduce language barriers and promote participation, as demonstrated by favorable responses from Spanish-speaking parents. Eighty-three percent reported feeling represented by parent and family groups, compared with 73% of English-speaking parents. Additionally, 83% of Spanish-speaking parents reported that families are included in planning school activities, compared with 68% of English-speaking parents. These results suggest that translation services contributed positively to equitable access and engagement.

Action 2.3 was effective in expanding family participation through monthly assemblies, Back-to-School Night, family activities, and cultural events. The number of parent volunteers increased from 67 in 2024–25 to 85 in 2025–26. Survey results also showed a slight increase, from

63% to 64%, in parents who felt empowered to play a meaningful role in school decision-making. While participation increased, additional efforts are needed to connect event attendance and volunteering with meaningful involvement in school planning and decision-making.

Action 2.4 was effective in maintaining strong relationships with military-connected families and the broader school community. Survey results showed that 83% of parents felt engaged with the school, 83% felt comfortable approaching school administration with concerns, and 90% felt comfortable approaching teachers about their child's progress. These results reflect strong levels of trust, accessibility, and communication.

Overall, the actions made positive progress toward the goal. Future efforts will focus on increasing survey participation, broadening representation among educational partners, expanding opportunities for meaningful feedback, and continuing to strengthen communication, transparency, and family engagement.

## Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

### SUCCESSFUL ACTIONS:

Action 3.1 provided funding for the implementation of the YouthTruth Survey of students, families, and staff to measure school climate and culture. The survey was fully implemented as planned with a 100% response rate from students, a 43% response rate from families, and a 57% response rate from staff. The survey was successful in providing the district with data to measure key areas like engagement, belonging, emotional and physical safety, and teacher-student relationships. The data helped the district identify strengths and gaps in the school climate that may be impacting learning and well-being.

Action 3.2 provided for strengthening a physically and emotionally safe, inclusive environment that supports student engagement and ensures all students are present, connected, and ready to learn.

Action 3.3 provided for the maintenance of facilities including classrooms, the multipurpose room, and other school facilities to ensure a safe, secure, and inviting learning environment that instills pride. The action was fully implemented as planned. However, the district continues to face ongoing challenges. Due to budget constraints, custodial and landscaping services must be contracted out. Additionally, the condition of aging facilities remains a persistent issue, requiring the district to increase maintenance staff hours in order to address rising maintenance demands and ensure that the school environment remains safe, clean, and functional.

Action 3.4 provided for counseling services to support student's social and emotional needs. This action was fully implemented as planned. This remains a challenge; however, in response to the increasing demand for counseling services, the district expanded the contracted time from 7 hours per day, 3 days a week, to 8 hours per day, 3 days a week during the 2024–25 school year. The contracted time will return to 7 hours per day, 3 days a week in the 2025-26 school year.

Action 3.5 provided funding to maintain the play areas. The action was successful and fully implemented as planned. In 2023-24 major updates were made to the TK playground and in the summer of 2023, major upgrades were made to the large playground structure. For the 2024-25 school year, work was limited to maintenance of all play areas. During the 2025-26 school year, upgrades were made to the TK/K play areas and maintenance of all play areas.

Action 3.6 provided for a standards-aligned physical educational program. This action was fully implemented as planned. There were no challenges with implementing this action, however, the district increased the hours of the PE specialist from a half day to a 7-hour day to give students increased access to physical education opportunities.

Action 3.7 provided students with after-school extended enrichment opportunities including art and coding. This action was implemented as planned.

Action 3.8 provided funding for additional chromebooks for new classroom teachers and replenishment of current chromebooks to maintain a 1:1 ratio. The action was fully implemented and successful as planned with purchases for 3rd grade completed.

Action 3.9 maintained funding for the STEAM lab and the garden. The action was successful and fully implemented as planned. Staff assumed responsibilities and workload, ensuring continuity of the programs.

Action 3.10 provided for a six-week summer program for students through a third-party vendor. This action was fully implemented as planned through a contract with Champions to provide extended learning opportunities and a summer camp. The challenge is the district has contracted for a targeted number of students and is working to fill those spots with last-minute enrollments.

Action 3.11 provided for the maintenance of technology including chromebook updates, ipad support, the internet, and security infrastructure. The action was fully implemented as planned through an outside vendor. The challenge was increasing costs beyond planned expenditures due to late student enrollment costs associated with onboarding and additional technology-related warranty work.

Action 3.12 provided funding for contracting with a vendor to provide a before- and after-school program for students. This action was fully implemented as planned. The contractor is challenged with recruiting bilingual staff to work with our English learners.

#### CHALLENGING ACTIONS:

Action 3.9 maintained funding for the STEAM lab and the garden. The action was challenging as planned. Staff assumed responsibilities and workload, ensuring continuity of the programs.

Action 3.13 funded a 0.1 FTE library clerk to support literacy and provide opportunities for students to access books and enrichment. The action also provided funding for a library accounting system with the Follet Software. This action was fully implemented as planned with only one challenge, due to budget limitations, the district is unable to continue funding for the library clerk in the 2025-26.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 3.1 provided for the administration of the YouthTruth Survey of students, families, and staff to measure school climate and culture. The survey was effective in making progress toward the goals due to the valuable data that was provided. There was a 100% response rate from students, a 43% response rate from families, and a 57% response rate from staff.

Actions 3.2 provided for the continued support and creation of a system of MTSS for all students including, ELL, students with disabilities, SED, and military connected families.

Action 3.3 provided for the maintenance of facilities including classrooms, the multipurpose room, and other school facilities to ensure a safe, secure, and inviting learning environment that instills pride. The action was effective in making progress toward the goal as evidenced by the "good" rating overall on the Facilities Inspection Tool (FIT). The effectiveness of this action was further supported by responses from the family survey in which 69% of parents stated they "feel proud of the school."

Action 3.4 provided targeted counseling support. The district took effective steps to continue the counselor's work hours, thereby enhancing the availability of support services. Student's responses to the survey indicate an upward trend in three areas. 1) the percentage of students who agreed they "feel safe at school" increased from 45% in 2024-25 to 57% in 2025-26, 2) the percentage of students who "feel like an important part of school" increased from 25% in 2024-25 to 33% in 2025-26, and 3) the percentage of students who agreed with the statement, "When upset, there is an adult from school you can talk to," which increased from 55% in 2024-25 to 56% in 2025-26. These survey response supports the effectiveness of the district's action to increase counseling time and suggests that extending the counselor's hours had a positive impact on students' perception of available emotional support.

Action 3.5 provided funding to maintain the play areas. The investments made in the TK/K play areas during the 2025-26 school year were effective in making progress toward the goal, as the playgrounds remained safe and accessible for students. This is supported by the overall "good" rating on the Facilities Inspection Tool (FIT).

Action 3.6 provides for a standards-aligned physical educational program. This action was effective in making progress toward the goal, as all students received the required number of PE minutes each week. To support and sustain this outcome, the district maintained a PE specialist, ensuring consistent and comprehensive physical education instruction.

Action 3.7 and 3.10 work together to provide after- and before-school student supervision and enrichment courses including art and coding. These actions were effective in making progress toward the goal as evidenced by the indicators of student engagement in school. The attendance rate in 2025-26 was 93.06%, and the chronic absenteeism rate decreased from 11.3% in 2023-24 to 5.9% in 2025-26.

Actions 3.8 and 3.12 work together to provide staff and students with the tools necessary to succeed in a 21st-century learning environment. These actions were effective in making progress toward the goal, as demonstrated by the implementation of an up-to-date technology replenishment plan that ensures equitable access to current and reliable technology resources. Students, particularly those from low-income households, have increased opportunities to engage with digital learning platforms, develop essential technology skills, and access instructional resources that support academic achievement. There was an increased in local assessment proficiency of 11% in ELA and 1% in Math.

Action 3.9 maintains funding for the STEAM lab and the garden. These actions were effective in making progress toward the goal as evidenced by the indicators of student engagement in school and student performance in math and science. The indicators of student engagement include the attendance rate which was 94.9% in 2024-25 and the chronic absenteeism rate which decreased from 21.9% in 2022-23 to 11.3% in 2023-24.

Action 3.11 provides for a six-week summer program for students. The summer school program provides an opportunity to close achievement gaps in language arts and math. This action was partially effective in making progress toward the goal as evidenced by measures of student academic achievement. Student academic performance on the statewide assessments was mixed with an overall increase in ELA and overall decreases in math. The percentage of students who are at or above proficiency in ELA increased from 39% in 2023-24 to 43% in 2024-25. In the area of math, the percentage of students who are at or above proficiency in math also decreased from 46% in 2023-24 to 44% in 2024-25.

Action 3.13 funded a 0.1 FTE library clerk to support literacy and provide opportunities for students to access books and enrichment. The action also provided funding for a library accounting system with the Follet Software. This action was effective in making progress toward the goal as evidenced by the indicators of student engagement in school. The attendance rate in 2024-25 was 94.9%, and the chronic absenteeism rate decreased from 21.9% in 2022-23 to 11.3% in 2023-24. However, insufficient funds have resulted in a discontinuation of the library clerk in the 2025-26 school year.

There were no changes to the planned goal, metrics, or targeted outcomes. There was one change to the actions: Action 3.13 was deleted due to budget constraints (data technician).

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. - **LCFF Carryover — Percentage:** Specify the LCFF Carryover — Percentage identified in the LCFF Carryover Table from the prior LCAP year. If a carryover percentage is not identified in the LCFF Carryover Table, specify a percentage of zero (0.00%).
- **Total Percentage to Increase or Improve Services for the Coming School Year:** This percentage will not be entered; it is calculated based on the Projected Percentage to Increase or Improve Services for the Coming School Year and the LCFF Carryover —

Percentage. ***This is the percentage by which the LEA must increase or improve services for unduplicated pupils as compared to the services provided to all students in the coming LCAP year.***

- **Goal #:** Enter the LCAP Goal number for the action.

  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
