8.2 Facilities Update

Background: Supt. Markatos will discuss emergent needs and potential updates to facilities.

Plan:

Concrete Ramps, west of grade 1 classroom (#6). There are two concrete ramps west of Rm 6 which have deteriorated over time. The concrete around the posts supporting the railing is falling away and needs to be repaired to ensure the railing does not fail. In addition, the adjacent rain gutter needs to be repaired or replaced. This involves determining why the original underground drain pipe was by-passed. Currently rain water ends up seeping in-between the two ramps which will cause a future problem if not addressed. An estimate for the work is expected by Friday.

Rain Gutters. All the rain gutters need to be inspected next time there are heavy rains. This past winter, there was a leak in the Business Manager’s office, which may have come from an interior drain pipe or even a leak in the roof. Follow-up will have to wait until the next heavy rainfall.

Fields. Guillermo is busy every Wednesday mowing the play fields, in addition to his other jobs. We’ve also contacted Mr. McClelland who annually mows the surrounding fields and we hope to hear from him soon on summer mowing dates.

We've scheduled the RSP/intervention teacher interviews for Monday, May 5; we currently have two applicants with appropriate credentials and recommendations. The committee includes two teachers, a classified staff member, a parent and the principal.

presented that the eighth regular teacher position will be offset with one time monies that will need to resubmit the plan to the board to have all funds expended by June 2026. The District is trying to keep class sizes smaller. Our goal is 150 students.

8.4 Curriculum Update

Background: Supt. Markatos will discuss updates to the curriculum.

Plan: -CAASPP English Language Arts and Math testing is happening this week, with a break on Wednesday; make-up testing and the Science segment of the test is scheduled for Monday. The testing includes grades 3-6, and our teachers administered several practice tests during the past several weeks. Everyone has been very focused and committed to doing their best.

-LCAP: the other major curriculum task is the required progress report for our LCAP (Local Control Accountability Plan). We are currently writing the report and Chris is updating the budget numbers for the Plan. So far we are noting progress, and the updates will be provided to the Board during the Special Meeting on May 22.

-Art & Music Discretionary Block Grant: this program is ongoing and includes significant carryover that we're using to fund an eighth teacher. The plan needs to be updated to reflect our spending rationale.

-Extended Learning Opportunity Plan: this program provides funding for inter-session enrichment and academic support, which we use for our after-school and summer Champion programs.

9.1 Approval of DIBELS/mCLASS as Dyslexia Screener for the District.

Background: California law mandates that Local Educational Agencies (LEAs) screen students in kindergarten through 2nd grade for reading difficulties, including dyslexia, starting with the 2025-2026 school year. The 2023 Budget Act, signed by the Governor, requires this screening using tools approved by a panel of experts. This screening is intended to identify students at risk of reading challenges and provide early intervention.

Plan: Two Rock Union School District uses one of the state approved screeners, DIBELS/mCLASS for current intervention monitoring. The District is recommending the use of DIBELS/mCLASS as the selected Reading Difficulties Risk Screener to the Board for adoption.. The estimated three year cost of the package is \$4,574.00. It is anticipated that this

cost will be partially covered by the one-time allocation from the state for professional development in the use of the new reading screener.
